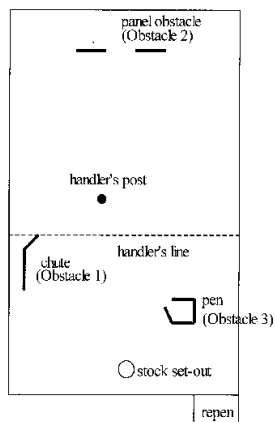
**Directions:**

Hemlock Fairgrounds, Hemlock, NY  
Approximately 30 miles from the Dome Arena, OESCA National Specialty show site in Henrietta, NY

From I-90. Take I-390 South towards Corning. Go 11 miles and take Exit 10. Take Route 20E 4-1/2 miles. Turn Right onto Route 15A. Go 8 -3/4 miles when you get into Hemlock, you will be coming down the hill and will pass the fire hall on your right. Then there is a gas station on the left as you start to go up the hill. Right before the top of the hill, the fairgrounds will be on your right. **If you are headed north on 15A**, the fairgrounds will be on your left. If you pass the gas station on your right, you've gone about a hundred yards too.

Day of event entries (if available) close ½ hour before briefing starts. You will only be notified if you did not get in and were put on the alternate list. Confirmations will be sent to entries submitted before September 7, 2010.

Pre-entries accepted thru Wednesday September 15, 2010 after which entries will only be accepted on site.

HCT 2<sup>nd</sup> Leg Qualifiers will get a green qualifying rosette and an HCT Title Certificate from AHBA. (Note: HCT Title requires two qualifying legs from AHBA) JHD qualifiers will get a green qualifying rosette. HTAD qualifiers will get a green qualifying rosette.

**HTAD High in Trial** will be awarded an AKC Large First Aid Kit offered by Linda Roeschmann.

**HTAD Reserve High in Trial** will be awarded \$20 Cash offered by Kristine Loland

**HTAD highest scoring Old English Sheepdog** will be awarded an OES figurine offered by Chris and Al Gaburri.

**HTAD First Place** in each class will be awarded and OES Leash Holder.

**HTAD Highest Scoring Senior Dog** (over 7 years of age) with placement-Digital PhotoKeychain

Livestock used will be dog-broke sheep in groups of three for test, groups of five will be used for trial. (\$200.00/ea. value)

**Please note:**

1. All dogs must be 6 months of age or older, and 9 months or older for trial.
2. All dogs must be current on their vaccinations & parasite free.
3. Dogs may wear only a Buckle or Snap Lock collar while working.
4. All dogs must be leashed or crated except when working.
5. Livestock seriously injured while being worked must be paid for by the owner or authorized agent of the dog causing the damage.
6. Spayed bitches or neutered dogs may participate.
7. Bitches in season may take part in tests, but must wait until all other dogs have participated.
8. Dogs should be trained to come reliably when called and stop (down, sit or stand-stay).
9. Dogs should not be near pen until shortly before their turn so they don't get themselves or the sheep too excited.
10. Please clean up after your dogs and obey any signs. Let's leave this beautiful ranch cleaner than when we arrived.
